Hydro One invites you to join us at our upcoming community information session to learn more about the Circuit D6 Relocation project, provide feedback and ask questions to members of our project team.

We are making an important investment in our 115-kilovolt transmission line, called Circuit D6. A section of Circuit D6 crosses an active area of the Department of National Defence's Garrison Petawawa military base. We are planning to relocate approximately 25 kilometres of the line between Chalk River Junction (JCT) in the Township of Laurentian Hills and Petawawa JCT in the Town of Petawawa, as shown on the reverse map. Moving the line will ensure our crews can safely perform refurbishment work on equipment nearing its end of life and ensure Hydro One infrastructure does not disrupt military activities. We initiated an environmental study under Hydro One's Class Environmental Assessment (EA) for Minor Transmission Facilities ([HydroOne.com/ClassEA](https://www.hydroone.com/ClassEA)) for the Circuit D6 Relocation project.

Covid-19 Protocols
