

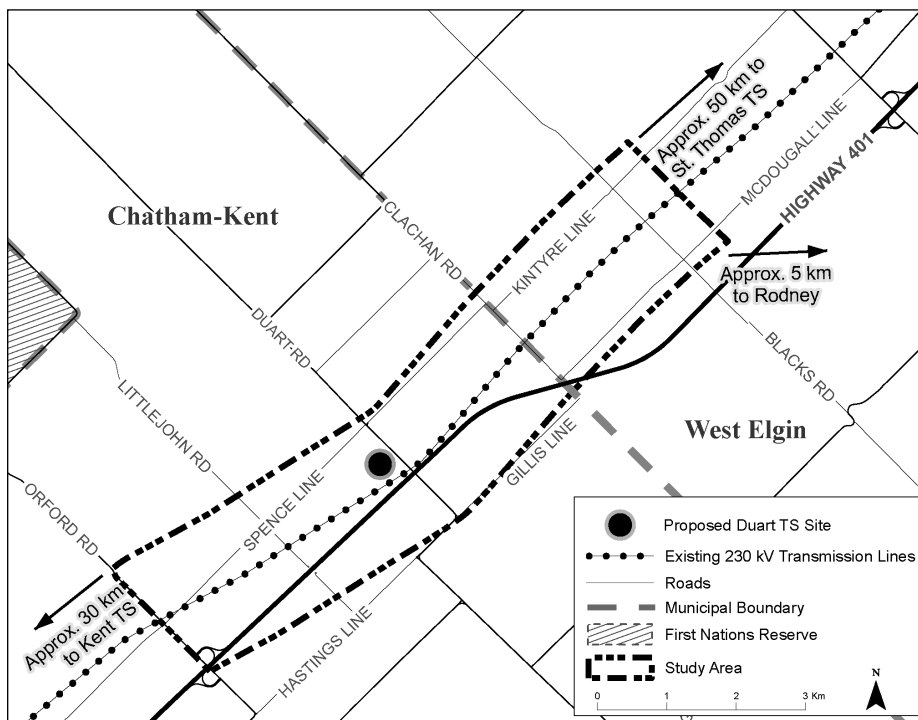
# Notice of Completion

## Class Environmental Assessment

### Duart Transformer Station (formerly Rodney Transformer Station)

Hydro One Networks Inc. (Hydro One) has completed the Class Environmental Assessment (EA) for the proposed new Duart Transformer Station (TS).

Hydro One's preferred location for the new transformer station is within the Municipality of Chatham-Kent, west of Duart Road in the community of Highgate (see map below). The proposed Duart TS will be connected to the existing double-circuit 230 kV transmission line that runs east-west along the north side of Highway 401.



A new TS is required to relieve supply problems at St. Thomas and Kent TS, the stations that currently serve the area. St. Thomas TS is reaching its end of life, and Kent TS is currently operating at capacity. This new station will improve the capacity of the electricity transmission system and ensure reliable supply for existing and future electrical needs in the Chatham-Kent and West Elgin areas.

Subject to completion of the Class EA process, Hydro One is targeting to have the proposed facility in service by June, 2011.

#### How to Submit Your Input

In accordance with the *Class EA for Minor Transmission Facilities*, the draft Environmental Study Report (ESR) will be available for public review and comment for a 60-day period from Thursday, June 25 to Tuesday, August 25, 2009. If no concerns are expressed, the ESR will be finalized and filed with the Ministry of the Environment (MOE). The project will be considered acceptable and will proceed as outlined in the draft ESR. If questions or comments on the project cannot be resolved by Hydro One during the 60-day review period, the concerned stakeholder(s) may make a written request to the MOE to "bump-up" the project to an Individual EA as outlined in the Part II of the Ontario *Environmental Assessment Act*.
