AND IN THE MATTER OF an application under the *Ontario Energy Board Act, 1998*, S.O. 1998, c. 15, Schedule B to amend Hydro One Networks Inc. and Thunder Bay Hydro Electricity Distribution Inc.'s distribution licences.

AMENDED PROCEDURAL ORDER No. 1

Hydro One Networks Inc. ("Hydro One") and Thunder Bay Hydro Electricity Distribution Inc ("Thunder Bay") filed a joint application with the Ontario Energy Board, received on November 18, 2008, under the *Ontario Energy Board Act, 1998*, S.O. 1998, c. 15, Schedule B. The Board has assigned File Number EB-2008-0347 to this application.

The Board issued a Notice of Application and Hearing on December 5, 2008. The Board has received several letters of comment from affected customers who state that they have not had adequate opportunity to make representation to the Board. In view of these comments, the Board has decided to extend the period for written comments to be made to the Board.

If affected customers have already sent a letter to the Board, the decision maker will consider that letter, as well as any other letters filed with the Board in response to this procedural order.

The Board has received an intervention request from Mr. Steve McLeod. The Board grants Mr. McLeod intervenor status.

2. If the applicants wish to respond to the letters, such responses must be filed with the Board and copied to any party that wrote a letter by **March 9, 2009**.
