Hydro One Networks Inc. has applied to the Ontario Energy Board to change its electricity distribution rates effective January 1, 2023. If the application is approved as filed, a typical residential customer and a typical general service customer of Hydro One Networks Inc. in the Orillia and Peterborough service areas would see the following change:

	Monthly Bill Impact	
Rate Class	Orillia	Peterborough
Residential 750 kWh	(\$0.28) per month	(\$0.22) per month
General Service less than 50kW (2,000 kWh)	\$10.00 per month	\$5.20 per month

The rates are determined using an OEB-approved formula which is tied to inflation and other factors intended to promote efficiency.

Hydro One Networks Inc. has also applied to dispose of the balances in certain deferral and variance accounts including accounts that are collectively referred to as Group 2 accounts. The above-noted bill impacts include Hydro One Networks Inc.'s request to refund customers the amounts resulting from the disposition of the Group 2 deferral and variance accounts.

Other customers, including businesses, may also be affected. Please review the application for the complete list of approvals requested by Hydro One Networks Inc.

THE ONTARIO ENERGY BOARD WILL HOLD A PUBLIC HEARING

The Ontario Energy Board (OEB) will hold a public hearing to consider Hydro One's application. We will determine whether the company has used the applicable models and formulas required by the OEB. We will also hear questions and arguments from individuals that have registered to participate (called intervenors) in the OEB's hearing. At the end of this hearing, the OEB will decide what, if any, rate change will be allowed.

The OEB is an independent and impartial public agency. We make decisions that serve the public interest. Our goal is to promote a financially viable and efficient energy sector that provides you with reliable energy services at a reasonable cost.

BE INFORMED AND HAVE YOUR SAY

You have the right to information regarding this application and to be involved in the process

- You can review Hydro One's application on the OEB's website now
- You can file a letter with your comments, which will be considered during the hearing
- You can become an intervenor. As an intervenor, you can ask questions about Hydro One's
 application and make arguments on whether the OEB should approve Hydro One's request. Apply
 by September 7, 2022 or the hearing will go ahead without you and you will not receive any further
 notice of the proceeding
- At the end of the process, you can review the OEB's decision and its reasons on our website

The OEB does not intend to consider cost awards for this hearing.
