NOTICE OF COMPLETION DRAFT ENVIRONMENTAL STUDY REPORT



Barrie Area Transmission Upgrade

Hydro One Networks Inc. (Hydro One) has completed a draft Environmental Study Report (ESR) for the proposed Barrie Area Transmission Upgrade project. The purpose of the project is to ensure an adequate and reliable supply of power to meet the growing electricity demands of the region. The project consists of replacing the two existing single-circuit 115 kilovolt (kV) transmission lines and wooden structures with a new, two-circuit 230 kV transmission line on steel structures along the existing transmission corridor. The project would also involve upgrades to the existing Barrie Transformer Station (TS) and Essa TS.

The proposed project is subject to the provincial *Environmental Assessment Act* and is being planned in accordance with the approved Class Environmental Assessment (EA) for Minor Transmission Facilities (Hydro One, 2016). Subject to the outcome of the Class EA, construction could begin in spring 2019.

HOW TO PROVIDE YOUR INPUT

In accordance with the Class EA process, Hydro One is providing notice of its intent to proceed with the proposed project. The draft ESR will be available for a 30-day public review and comment period from January 29, 2018 to February 27, 2018. The draft ESR can be viewed on Hydro One's website at:



Hydro One will respond to and make best efforts to resolve any issues raised during the review period. If no issues are raised during the review period, Hydro One will finalize the ESR and file it with the Ministry of Environment and Climate Change (MOECC). The project will be considered acceptable and may proceed as outlined in the ESR.



The Environmental Assessment Act has provisions for interested parties to ask for a higher level of assessment if they feel that outstanding issues have not been adequately addressed.
