We invite you to attend our second round of community open houses for an update on Hydro One's important work to replace a critical underground transmission cable that serves Toronto's downtown core. Since the Class Environmental Assessment was initiated for this project in May 2018, we have been reviewing environmental and technical data, and collecting feedback and input on alternative routes and construction methods. Based on this analysis and information, we have now selected our preferred route, Tunnel Route 1, shown on the reverse map. The proposed underground tunnel would run between Terauley Transformer Station (TS) and Esplanade TS at a depth of approximately 25 metres/82 feet below ground within road allowance.

On the map, you will see proposed locations for shafts, which are required to access and maintain the underground cable.

- **Location A** - Entry shaft to be located on Hydro One's property at Esplanade TS
- **Location B** - Mid shaft to be located on road allowance near the intersection of Sherbourne Street and Shuter Street
- **Location C1 or C2** - Exit shaft to be located inside or near Terauley TS
