Please be advised that I am the solicitor for Hugh and Cathy Campbell who reside at the above-noted address. They obtained a notice of the above-noted study report and attended at the municipal office to try to determine how this is going to affect their property.

At the present time there is a hydro tower located on the rear of their property. There is also a hydro tower on the right-of-way near the Canadian Pacific Railway. It is their understanding, from the documentation and information they have been provided, that there is now going to be a third tower between the two above-mentioned towers.

My clients and I have been unable to determine, from the documentation, where the third tower is going to be located and how it is going to affect their property.

Dear Mr. Reaume:

I have reviewed your letter dated February 25, 2010 and have prepared the following response in regards to Mr. and Mrs. Campbell's concerns and questions on our Supply to Essex County Transmission Reinforcement project.

1. We have a registered easement for the tower on the Campbell's property. The easement was registered on October 28, 1940 as Instrument Number 25866 in the Registry Office for the County of Essex. We have no plans to remove and relocate this tower.
2. At this time we do not know the precise location of the new tower. The centre-line of the proposed right-of-way is 100 feet from the centre-line of the existing 115kV right-of-way and 150 feet from the centre-line of the 230kV line. I have attached a cross-section of the right-of-way.
3. The environmental effect of the additional tower is predicted to be minimal, since the land is currently farmed and this use is compatible with transmission lines.
4. As discussed above, the exact location of the tower has not been determined and therefore we cannot predict the view from the rear of their property, but we can assume the additional tower will be visible.

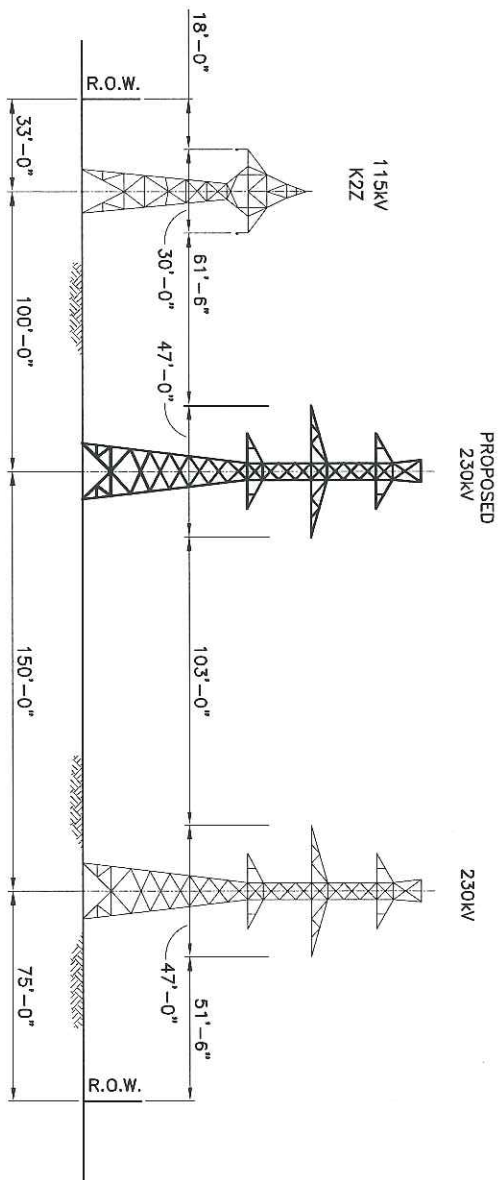
We expect that this line will not be constructed for several years. In addition to the Class Environmental Assessment approval, the project would also require a Leave to Construct approval from the Ontario Energy Board. We would be happy to provide Mr. And Mrs. Campbell with more detailed information on the tower location and the view from their yard once all approvals are completed and we are in the design phase of this project.
