

ONTARIO ENERGY BOARD NOTICE

Centre Wellington Hydro Ltd. has applied to amend the area where it is licensed to provide electricity distribution service. Learn more. Have your say.

Centre Wellington Hydro Ltd. has applied to the Ontario Energy Board for an order to amend the area where it is licensed to provide electricity distribution service to include lands presently in Hydro One Networks Inc.'s licensed service area.

In particular, Centre Wellington Hydro has asked to amend its licence to:

- Enable Centre Wellington Hydro to continue to serve the Groves Memorial Community Hospital which is relocating to lands within Hydro One Networks' service area;
- Include development lands owned by the County of Wellington adjacent to the lands where the hospital is to be relocated and currently within Hydro One Networks' service area;

As part of its request, Centre Wellington Hydro is also asking to transfer two customers from Hydro One Networks to Centre Wellington Hydro.

THE ONTARIO ENERGY BOARD IS HOLDING A PUBLIC HEARING

The Ontario Energy Board (OEB) will hold a public hearing to consider whether to grant Centre Wellington Hydro the proposed service area amendment. We will question Centre Wellington Hydro and Hydro One Networks on this matter. We will also hear arguments from individuals and from groups that represent the customers of both Centre Wellington Hydro and Hydro One Networks. At the end of this hearing, the OEB will decide whether to amend Centre Wellington Hydro's licence as requested.

The OEB is an independent and impartial public agency. We make decisions that serve the public interest. Our goal is to promote a financially viable and efficient energy sector that provides you with reliable energy services at a reasonable cost.

BE INFORMED AND HAVE YOUR SAY

You have the right to information regarding this application and to be involved in the process. You can:

- review Centre Wellington Hydro's application on the OEB's website now.
- file a letter with your comments, which will be considered during the hearing.
- become an active participant (called an intervenor). Apply by **September 8, 2014** or the hearing will go ahead without you and you will not receive any further notice of the proceeding.
- at the end of the process, review the OEB's decision and its reasons on our website.

ORAL VS. WRITTEN HEARINGS

There are two types of OEB hearings – oral and written. Centre Wellington Hydro has applied for a written hearing. The OEB is considering this request. If you think an oral hearing is needed, you can write to the OEB to explain why.

PRIVACY

If you write a letter of comment, your name and the content of your letter or the documents you file with the OEB will be put on the public record and the OEB website. However, your personal telephone number, home address and email address will be removed. If you are a business, all your information will remain public. If you apply to become an intervenor, all information will be public.

This hearing will be held under section 74 of the Ontario Energy Board Act, 1998, S.O. 1998 c.15 (Schedule B).
