

# NOTICE OF A RATE HEARING

## Hydro One Networks Inc. has applied to change its electricity transmission rates effective January 1, 2025

Hydro One Networks Inc. (Hydro One) has applied to the Ontario Energy Board (OEB) for approval to change its electricity transmission rates effective, January 1, 2025. The application seeks an Order for approval of the following:

- Rates revenue requirement for 2025
- Approval to dispose of the balance in the Excess Export Service Revenues Variance Account as of December 31, 2023
- Approval of the Export Transmission Service rate for 2025

If the application is approved as filed, the monthly bill of a typical residential and general service electricity distribution customer would see the following change effective January 1, 2025:

<b>Residential (750 kWh)</b>	<b>\$0.83 per month</b>
<b>General Service less than 50kW (2,000 kWh)</b>	<b>\$1.84 per month</b>

Other customers, including businesses, will also be affected.

Any change to the provincial transmission rate will be reflected on the delivery line of the electricity bill for all electricity customers in Ontario. It is important to review the application carefully to determine whether you may be affected by the proposed changes.

## YOU SHOULD KNOW

There are three types of OEB hearings: oral, electronic and written. The applicant has requested the application be disposed of without a hearing. The OEB is considering the request. If you think a hearing is needed, you can write to us to explain why.

During a hearing, we hear questions and arguments from participants about the case. We also hear questions and arguments from participants that have registered as Intervenor. After a hearing, we will decide whether to approve the application.

### IMPORTANT DATES

You must engage with the OEB on or before **August 26, 2024** to:

- Provide input on the hearing type (oral, electronic or written)
- Apply to be an intervenor

If you do not, the hearing will move forward without you, and you will not receive any further notice of the proceeding.


### PRIVACY

If you write a letter of comment, your name and the content of your letter will be put on the public record and the OEB website. If you are a business or if you apply to become an intervenor, all the information you file will be on the OEB website.
