

**Hydro One Networks Inc.**  
**Little NHL Social Media Contest – January–February 2019**

**Rules and Regulations**

**By entering the Contest (defined below), entrants agree to abide by these Rules and Regulations and will be deemed to have received, understood and accepted these Rules and Regulations by participating in the Contest.**

Hydro One Networks Inc. (hereinafter “Hydro One”) Little NHL social media contest (the “Contest”) will run from 11:00 a.m. ET on January 17, 2019 until 11:59 p.m. ET on February 22, 2019 (the “Contest Period”).

**Prizes**

The winning submission will receive new hockey sticks for each member of their participating Little Native Hockey League (Little NHL) team.

**Entry**

No purchase is necessary, but your entry must be received by one of the means described below.

**SOCIAL MEDIA ENTRY:**

During the Contest Period, you must successfully post to your personal Facebook or Instagram account with a photo of your participating Little NHL team showcasing team spirit and tag Hydro One along with #WinAsOneTeam. You must also provide your contact information by filling out the submission form on Hydro One’s website.

**WEBSITE ENTRY:**

For the participating Little NHL teams that do not have a Facebook or Instagram account but still wish to enter the Contest, they can fill out the submission form on our website and upload a photo of their team showcasing team spirit.

**ALTERNATIVE ENTRY:**

You may enter other than as set out above by sending or delivering, with your name, address, and telephone number, a photo of their team showcasing team spirit to Hydro One Corporate Communications, Little NHL Social Media Contest, 483 Bay St., 8th Floor - South Tower, Toronto, Ontario M5G 2P5.

Any other method of entry is void. Non-compliance with any entry procedure will result in disqualification. All entries must be received by 11:59 p.m. ET February 22, 2019 (the “Contest Closing Date”).

**Draw**

On or about 10:00 a.m. ET on February 25, 2019, in Toronto, Ontario, Hydro One will randomly draw one (1) entry from all eligible entries received. To win, a selected entrant must correctly answer the mathematical skill-testing question and must return the properly executed release form within the specified time. A selected entrant will be notified by telephone, email and/or mail approximately the first week following the draw. If the skill-testing question is answered incorrectly or if a selected entrant does not respond to the attempts to contact him/her/it or the properly executed release form is not returned within the specified time, then he/she/it will be disqualified from the Contest and an alternate entry will be randomly drawn from the pool of eligible entries. If a selected entrant cannot be reached within two days

after the first attempt of notification, his/her/its opportunity to win the prize will be forfeited and another selected entrant will be randomly drawn. Hydro One will not be responsible for failed attempts to contact a selected entrant.

### **General Rules**

Any entry which is in violation of these Rules and Regulations or received after the end of the Contest Period is void, and the entrant shall be disqualified from the Contest.

The Contest is open to teams participating in the Little NHL tournament. Entrants must be residents of Ontario who are eighteen (18) years of age or older.

Contest excludes employees, agents and representatives of any of the following, and anyone with whom such persons are living (whether related or not) and a member of any such person's immediate family (regardless of where they live): Hydro One Networks Inc., its advertising and promotional agencies, and their affiliated companies. In these Rules and Regulations, "immediate family" includes mother, father, brother, sister, son, daughter, partner and/or spouse. The Contest is not in any way sponsored, endorsed, administered by, or associated with Facebook or Instagram.

Chances of winning depend on the number of eligible entries received. Entries are subject to verification by Hydro One, in each case in its sole discretion. The Contest is subject to all applicable federal, provincial, and municipal laws and regulations. All decisions of the judges are final, and the Released Parties (defined below) shall not be responsible for any errors or negligence that may occur in connection with the Contest.

The selected entrant will also be required to sign a declaration and release form (the "Release Form") confirming compliance with these Rules and Regulations, acceptance of the prize as awarded, without substitution and releasing Hydro One, its affiliated and related companies, advertising and promotional agencies, and their respective shareholders, directors, officers, employees, agents, representatives, successors and assigns (collectively, the "Released Parties") from any liability in connection with the prize or the Contest. Each person in the winning photo must also sign a Release Form granting Hydro One permission to share the winning photo to its social media channels including Facebook, Instagram, Twitter and LinkedIn. The Release Form must be returned within the time period specified on the Release Form or the prize will be forfeited.

No communication will be entered into except with the selected entrant(s). By entering the Contest, all entrants consent to the use, without compensation, of their name, city of residence, audio/video image, statements, and/or photograph in any related publicity. The prizes are non-transferable and cannot be redeemed for cash.

By entering the Contest, all entrants represent and warrant that (i) their entry and submission form, including any material comprising their entry and submission form (e.g. name, user name, profile picture, etc., as applicable) and any material submitted with their entry and submission form (e.g. photograph, written submission, or other form of submission, as applicable) (all such material, collectively, the "Entry Material") is original to the entrant, (ii) the entrant has all necessary rights in and to the Entry Material to enter the Contest, including the consent of any third parties whose personal information is included in the Entry Material, and (iii) the Entry Material does not contain, depict, include or involve content that is, or could reasonably be considered to be, inappropriate, unsuitable or offensive, as determined by Hydro One.

If there are any identifiable individuals in the photo, it is the entrants' responsibility to obtain, prior to submission of the entry, the consent of each such individual. If any individual(s) is under the age of 18, the consent must be obtained from the individuals' parent or legal guardian. Photos that do not have such consents are ineligible.

Notwithstanding anything contained in these Rules and Regulations, the Released Parties do not accept any responsibility for loss, damage or claims from any cause whatsoever relating to the Contest. The Released Parties will not be responsible for late, lost, illegible, incomplete, falsified and/or destroyed entries and all such entries are void. The Released Parties will not be responsible for any failure of the website during the Contest or for any problems or technical malfunction of computer online systems, servers, access providers, computer equipment, software, failure of any email, online or Internet entry to be received by Hydro One, whether due to technical problems, traffic congestion on the Internet or at any website, or any combination thereof or any other cause, including any injury or damage to an entrant's or any other person's computer related to or resulting from playing or downloading any material in the promotion.

The use of an invalid email address will void the entry. Entrants using multiple email addresses to enter the Contest will be disqualified from the Contest. If the identity of an entrant is disputed, the authorized account holder associated with the email account at the time of entry will be deemed the entrant. A selected entrant may be required to provide proof that he/she is the authorized account holder of the email address associated with the selected entry.
