

**CONFIRMATION OF SATISFACTION OF 15 METRES SITING REQUIREMENT
ESTABLISHED UNDER SUBSECTION 2(1)3 OF O.REG. 274/18
[NON-VIRTUAL NET METERING DEMONSTRATION PROJECTS]**

INSTRUCTION NOTES FOR FACILITY OWNERS/OPERATORS AND CONFIRMING SURVEYOR LICENSED BY ASSOCIATION OF ONTARIO LAND SURVEYORS:

THE ATTACHED FORM OF CONFIRMATION is used for a renewable energy generation facility at which one or more solar photovoltaic collector panels or devices use light to generate electricity ("**Facility**") which is not a Virtual Net Metering Demonstration Projects **and** where the Facility is **EITHER**:

- (a) not located on the roof or a wall of a building or structure; **OR**
- (b) located on the roof or a wall of a building or structure a primary purpose of which is to support or maintain the Facility.

Subsection 2(1)3 of O. Reg. 274/18 made under the *Electricity Act, 1998* (Ontario) titled "Siting Restrictions for Renewable Energy Generation Facilities" ("**O. Reg. 274/18**") requires that the Facility be located at least 15 metres away from the boundaries of the Property on which the Facility is located. Subsection 2(3) of O. Reg. 274/18 requires that the confirmation that the Facility satisfies the requirement in Subsection 2(1)3 be **SIGNED** by a land surveyor licensed by the Association of Ontario Land Surveyors.

In accordance with Subsection 2(3) of O. Reg. 274/18, **THE ATTACHED FORM OF CONFIRMATION MUST BE SIGNED** by a land surveyor licensed by the Association of Ontario Land Surveyors. Confirmations signed by owners and/or operators of the Facility or persons that are not land surveyor licensed by the Association of Ontario Land Surveyors will be rejected.

- E. the Facility satisfies the connection requirement in subsection 2(1)3 of O. Reg. 274/18 that the Facility be located at least 15 metres away from the boundaries of the Property on which the Facility is located; and
- F. I understand that Hydro One is relying on my Confirmation in order to connect the Facility to its distribution system.

THIS CONFIRMATION shall be governed by and construed in accordance with the laws of the Province of Ontario and the laws of Canada applicable therein.
