# Self-declaration form instructions

The Ontario Electricity Rebate ("**OER**") provides eligible customers with a 13.1% reduction on the amount of their bill before HST (O. Reg. 363/16, the "**Regulation**"). **NOTE** – OER eligibility under the Regulation has been updated in 2022 (O. Reg. 216/22). The updated eligibility is shown on this instruction notice.

# The following customers are automatically eligible for the OER and <u>do not</u> need to complete the self-declaration form:

- Residential and Small Commercial customers (billed under a Residential or General Service Energy rate class) using less than 50 kW.
- Commercial accounts that are greater than 50 kW but use less than 250,000 kWh annually.

# The following customers are eligible for the OER but need to complete the selfdeclaration form in order to receive the rebate:

- Commercial customers (billed under a General Service Demand or Sub-transmission rate class) who: (1) have a demand for electricity greater than 50kW, (2) use more than 250,000 kWh a year, and (3) fall under one of the following eligibility criteria:
  - Farming Business
  - · Long-term care home, other than an account that is also in respect of a hospital
  - · Multi-unit complexes that are predominantly residential, such as condominium and apartment buildings
  - Common elements in multi-unit complexes that are predominantly residential (as of July 1, 2022)Retirement residence (as of July 1, 2022)
  - Mobile home park (as of July 1, 2022)
  - (definitions for the above terms are provided on the next page)
- In addition, some accounts that are not eligible but were receiving the former 8% Provincial Rebate that was in place before the OER was introduced on November 1, 2019 receive the OER under a legacy exemption. You should complete this form only if your account relates to:
  - A multi-unit complex
  - Any common elements of a multi-unit complex
  - A retirement residence
  - A mobile home park
- Please refer to the final section of these Instructions for a list of ineligible premises.

**Note**: If your account is using >50 kW and >250,000 kWh/year and is a Farming Business or a Multi-Unit Complex as defined below (does not apply to long-term care homes), you may also be eligible for Regulated Price Plan ("**RPP**") pricing and can apply using the link below. Residential and Small Commercial customers using less than 50 kW and commercial accounts that are greater than 50 kW but use less than 250,000 kWh annually automatically qualify for RPP and do not need to apply. ## **Definitions**

Unless otherwise noted, the following definitions are from the Regulation, as amended:

"common elements", in respect of a multi-unit complex, means any part of the multi-unit complex that is not a unit "farming business" refers to a consumer that:

- 1. carries on a business that is a farming business for the purposes of the Farm Registration and Farm Organizations Funding Act, 1993, and
- 2. holds a valid farm business registration number assigned under that Act or the consumer's obligation to file an application for a farming business registration number was waived pursuant to an order made under subsection 22(6) of that Act.

"**long-term care home**" means a long-term care home within the meaning of the *Fixing Long-Term Care Act, 2021*"**mobile home**" means a dwelling that is designed to be made mobile and that is being used as a permanent residence (*Residential Tenancies Act, 2006*)

"**mobile home park**" means the land on which one or more occupied mobile homes are located and includes the rental units and the land, structures, services and facilities of which the landlord retains possession and that are intended for the common use and enjoyment of the tenants of the landlord (*Residential Tenancies Act, 2006*)

"**multi-unit complex**" is defined as a building or related group of buildings containing two or more units, and that is not ineligible as described below

"qualifying unit" is defined for OER purposes as a unit that,

- 1. consists of a self-contained room or set of rooms,
- 2. contains kitchen and bathroom facilities that are for the sole use of the unit, and
- 3. is occupied and used as a residence

"retirement residence" means a multi-unit complex that meets the following requirements but is not a long-term care home:

- 1. At least 50 per cent of the units in the multi-unit complex are occupied or intended to be occupied as a permanent residence by at least one person who is 65 years of age or older and who is not related to the operator of the multi-unit complex.
- 2. The total number of persons referred to in paragraph 1 who occupy or are intended to occupy the total number of units described in that paragraph is at least six.

#### "unit" means:

- 1. A unit as defined in the Condominium Act, 1998,
- 2. A residential unit or a rental unit, as those terms are defined in subsection 2 (1) of the Residential Tenancies Act 2006,
- 3. A member unit or a non-member unit, as those terms are defined in the Co-operative Corporations Act, or
- 4. Premises that is a demised premises for the purposes of the Commercial Tenancies Act.

"unit" does not include a unit that is used or intended for parking or storage purposes or for the purpose of providing space for services, recreation or other facilities or mechanical installations.

# Amulti-unit complex is <u>ineligible</u> if any part of it is one of the following:

- A hotel, motel, motor hotel, resort, lodge, tourist camp, cottage or cabin establishment, inn, campground, tourist home, bed and breakfast vacation establishment or vacation home
- A trailer park that is not a mobile home park
- · Living accommodation occupied by a person for penal or correctional purposes
- A hospital
- A premises that is subject to the Ministry of Correctional Services Act or the Child, Youth and Family Services Act, 2017
- Short-term living accommodation provided as emergency shelter
- · Living accommodation provided by an educational institution to its students or staff where:
  - the living accommodation is provided primarily to persons under the age of majority, or all major questions related to the living accommodation are decided after consultation with a council or association representing the residents, and
  - ii. the living accommodation is not intended for year-round occupancy by full-time students or staff and members of their households.

- A university, college of applied arts and technology or other entity that provides post-secondary education
- Premises that is identified by a NAICS code commencing with the digits 21, 22, 23, 31, 32 or 33 (i.e. in the mining, quarrying, oil and gas extraction, utilities, construction and manufacturing sectors)
