Hydro One will update your Account only upon receipt of this completed Declaration Form, and the Account(s) will remain on the Regulated Price Plan and/or receive the Ontario Electricity Rebate until you advise Hydro One, in writing, that the Account no longer qualifies or the eligibility period ends, whichever comes first.

Requirement to Notify of Change in Eligibility:

I confirm that should any of the Account(s) no longer meet the Farm Business Eligibility Requirements, I will provide a revised Declaration Form to Hydro One within 90 days of the date that the change in eligibility occurred.

Acknowledgements and Certification:

I acknowledge that it is an offence to make a false or deceptive statement in a document submitted under the *Ontario Rebate for Electricity Consumers Act, 2016* and certify that the information in this Declaration form is complete and accurate. I further acknowledge that I may be subject to a third party audit at any time to verify the accuracy of the information provided and could be liable for reimbursement of any funds overpaid.
