ONTARIO ENERGY BOARD NOTICE TO ALL CUSTOMERS OF HYDRO ONE NETWORKS INC.

Hydro One Networks Inc. has applied to increase the amount it charges to transmit electricity in Ontario.

Learn more. Have your say.

Hydro One Networks Inc. has applied to the Ontario Energy Board for approval of a plan to set the amount it charges for using its transmission system in each of the three years beginning on January 1, 2020 and ending on December 31, 2022.

If the application is approved as filed, Hydro One Networks Inc. estimates that the monthly bill of a typical residential customer using 750 kWh per month and a typical General Service < 50 kW customer using 2,000 kWh per month would increase by the following amounts:

Year	2020	2021	2022
Residential Bill Impact (per month)	\$0.77	\$0.56	\$0.59
General Service < 50 kW Bill Impact (per month)	\$1.83	\$1.32	\$1.39

The Ontario Energy Board's decision on this application will have an effect on all electricity consumers in Ontario. The cost of transmission is reflected in the delivery charges included on bills.

THE ONTARIO ENERGY BOARD IS HOLDING A PUBLIC HEARING

The Ontario Energy Board (OEB) will hold a public hearing to consider Hydro One Networks Inc.'s requests. We will also hear questions and arguments from individual customers and from groups that represent Hydro One Networks Inc.'s customers. At the end of this hearing, the OEB will decide what, if any, rate increase will be allowed.

If Hydro One Networks Inc.'s application is approved as filed, the OEB's review in years 2021 and 2022 will be limited to ensuring certain annual formulaic adjustments are made in accordance with the approved rate plan. The formulaic adjustments are tied to inflation and other factors intended to promote efficiency.

The OEB is an independent and impartial public agency. We make decisions that serve the public interest. Our goal is to promote a financially viable and efficient energy sector that provides you with reliable energy services at a reasonable cost.

BE INFORMED AND HAVE YOUR SAY

You have the right to information regarding this application and to be involved in the process.

- You can file a letter with your comments, which will be considered during the hearing.
- You can become an active participant (called an intervenor). Apply by **May 6, 2019** or the hearing will go ahead without you and you will not receive any further notice of the proceeding.
