1. Ariba Overview / Benefits

1.1 Overview

This Supplier Guide is intended for suppliers wishing to participate in sourcing events with Hydro One.

1.2 What is Ariba?

SAP Ariba is a cloud-based solution that reduces cycle times and administrative burdens during the source to order process. Hydro One is now using Ariba to launch sourcing events and to manage contracts. New processes, such as online sourcing RFx, automated approvals and eSignature capabilities, will allow for reduced sourcing turnaround time and enhanced contract fulfillment.

1.3 What are Ariba's Benefits to Suppliers?

SAP Ariba provides key benefits to Hydro One suppliers, including:

Process Efficiencies

- Contracts awarded faster with standard processes, such as online sourcing RFx and automated approvals, for quicker fullfillment
- System generated notifications received well in advance of key milestone dates

Increase Visibility

- Increased visibility through standard dashboards
- Increased visibility through system generated reports
- Ability to view all documents and communications in one repository
- Total contract life cycle management

2. Supplier Registration

2.1 How to Register

All suppliers who wish to participate in a Sourcing Event are required to register with Hydro One using the Ariba Network. In order to register, Suppliers must first obtain an invite by sending a request to SupplierContact@HydroOne.com. An invitation will be emailed back containing a registration link which will direct the Supplier to the registration process. During the registration process, Suppliers must complete the Supplier Questionnaire and update their Profile.

Note: Upon receiving the invitation to register, you will need to complete the process in Ariba using **Google Chrome** or **IE11**.

Legacy Suppliers - Registration Invitation

Hydro One will be sending an email invite to the legacy suppliers to register with the Ariba Network. Once that email is received, supplier may follow the Step by Step Registration guide outlined below. If you are a legacy supplier and you have yet to receive an invitation from Hydro One, please send an email to SupplierContact@HydroOne.com requesting an invitation. **Note**: Email invites will be sent to the main contact that originally setup the bidding account in the legacy system. This may not be the person responsible for contract negotiations with Hydro One.

2.1.1 Step by Step Registration Guide

a. Registration Page

Click on the provided link in the email invitation. The Ariba **Registration Page** will be displayed.

b. Company / User Account Information

Provide information on the Company Information section and User Account Information section. Populate the required fields. (Note: a. Please fill-up the fields directly in the text box, do not Copy and Paste. b. Email used must be valid.)

c. Terms & Conditions

Read and agree to the **Terms & Conditions** of Ariba.

d. Register Button

Ensure all details are correct. Once completed, select the **Register** button.



e. Activate Account

Verify your email address by clicking the link provided in the email sent by Ariba following your registration. Click the '**Click here to activate your Ariba account**' hyperlink or copy the link and paste it into a browser.

Once your email address has been verified, the Supplier Questionnaire would automatically be displayed.
