Rules and Regulations

By entering the Contest (defined below), entrants agree to abide by these Rules and Regulations and will be deemed to have received, understood and accepted these Rules and Regulations by participating in the Contest.

Hydro One Networks Inc. (hereinafter "Hydro One") Orillia 2020 Ontario Winter Games social media contest (the "Contest") will run from 8:00 a.m. ET on January 27, 2020 until 11:59 p.m. ET on February 27, 2020 (the "Contest Period").

Prizes

One (1) prize is available to be awarded to social media followers of Hydro One. The winning submission will receive a \$200 gift card to Skiis & Biikes.

Entry

No purchase is necessary, but your entry must be received by one of the means described below.

SOCIAL MEDIA ENTRY:

During the Contest Period, you must successfully follow Hydro One and Orillia 2020 Ontario Winter Games on Facebook or Instagram and comment on Hydro One's post with your favourite winter sport.

ALTERNATIVE ENTRY:

You may enter other than as set out above by sending or delivering, with your name, address, and telephone number, your favourite winter sport to Hydro One Corporate Communications, Orillia 2020 Ontario Winter Games Social Media Contest, 483 Bay St., 8th Floor - South Tower, Toronto, Ontario M5G 2P5.

Any other method of entry is void. Non-compliance with any entry procedure will result in disqualification. All entries must be received by 11:59 p.m. ET February 27, 2020 (the "Contest Closing Date").

Draw

On or about 10:00 a.m. ET on March 2, 2020, in Toronto, Ontario, Hydro One will randomly draw one (1) entry from all eligible entries received. To win, a selected entrant must correctly answer the mathematical skill-testing question and must return the properly executed release form within the specified time. A selected entrant will be notified by telephone, email and/or mail approximately the first week following the draw. If the skill-testing question is answered incorrectly or if a selected entrant does not respond to the attempts to contact him/her/it or the properly executed release form is not returned within the specified time, then he/she/it will be disqualified from the Contest and an alternate entry will be randomly drawn from the pool of eligible entries. If a selected entrant cannot be reached within two days after the first attempt of notification, his/her/its opportunity to win the prize will be forfeited and another selected entrant will be randomly drawn. Hydro One will not be responsible for failed attempts to contact a selected entrant.

General Rules

Any entry which is in violation of these Rules and Regulations or received after the end of the Contest Period is void, and the entrant shall be disqualified from the Contest.

The Contest is open to individual users on Facebook and Instagram. Entrants must be residents of Ontario who are eighteen (18) years of age or older.

Contest excludes employees, agents and representatives of any of the following, and anyone with whom such persons are living (whether related or not) and a member of any such person's immediate family (regardless of where they live): Hydro One Networks Inc., its advertising and promotional agencies, and their affiliated companies. In these Rules and Regulations, "immediate family" includes mother, father, brother, sister, son, daughter, partner and/or spouse. The Contest is not in any way sponsored, endorsed, administered by, or associated with Facebook or Instagram.

The use of an invalid email address will void the entry. Entrants using multiple email addresses to enter the Contest will be disqualified from the Contest. In the event of a dispute, entries will be deemed to have been submitted by the authorized account holder of the email address associated with the applicable Hydro One account.
